LIABILITY WAIVER FORM

Below you'll find a copy of the Liability Waiver Form that you'll receive to sign the day of the event. A parent or legal guardian will be required to sign in pen at the registration booth. We are providing it to you in advance so that you may read it prior to the event.

EMERGENCY AUTHORIZATION, DISCLAIMER, ASSUMPTION OF RISK, and WAIVER

I, _____, am the parent/guardian of _____.

As the parent/guardian, I have the authority to enter into a binding agreement on behalf of the Participant and myself. The Participant desires to attend the Amon Gordon Life Skills Football Camp sponsored by the National Football League (NFL) Youth Football Fund (YFF). I hereby grant permission for Participant to attend the Amon Gordon Life Skills Football Camp and acknowledge that he/she is physically able to participate in camp activities.

Medical Care: I hereby authorize the coaches, staff, volunteers or other representatives of the Amon Gordon Life Skills Football Camp to act for me according to their judgment in any emergency requiring medical attention such as first aid to the Participant, emergency transportation, and any other medical treatment performed by physicians, paramedics and other medical personnel, in the event of any illness, accident or injury to Participant during his/her attendance at camp. I understand that the Amon Gordon Life Skills Football Camp does not provide Participant with any life, medical, or liability insurance for any illness, accident, injury, loss or damage that may arise in connection with Participant's attendance at camp.

Assumption of Risk: I hereby waive and release the coaches, staff, volunteers or other representatives of the Amon Gordon Life Skills Football Camp, Mira Mesa High School, and San Diego Unified School District from any and all liability for any injuries or illness incurred by Participant while at camp. I acknowledge that participation in a non-padded football camp involves contact with considerable force, and the risk of severe, permanent physical injury including bruises, scrapes, strained, sprained or torn muscles, tendons or ligaments, broken bones, dislocation of joints, concussion, brain damage, nerve and spinal cord injury, paralysis and/or death. I am a competent adult and I willingly and voluntarily accept and assume all such risk of my own free will on behalf of the Participant.

Release from Liability: I hereby release, discharge and agree to hold harmless to the fullest extent permitted by law the coaches, staff, volunteers or other representatives of the Amon Gordon Life Skills Football Camp, Mira Mesa High School and San Diego Unified School District from any and all injuries (including death), losses, damages, claims (including negligence claims), lawsuits and any other liability of any kind directly or indirectly arising out of or in connection with the Participant's attendance at the Amon Gordon Life Skills Football Camp.

Covenant Not to Sue: Participant and I will not initiate any lawsuit, court action or other legal proceeding against the coaches, staff, volunteers or other representatives of the Amon Gordon Life Skills Football Day Camp, Mira Mesa High School, or San Diego Unified School District, nor join in or assist in any prosecution of any claim for money damages which anyone may have, on account of injuries (including death), losses or damages sustained by Participant or others in connection with Participant's attendance at camp.

Indemnity: Participant and I will hold harmless, indemnify, and reimburse the coaches, staff, volunteers or other representatives of the Amon Gordon Life Skills Football Camp, Mira Mesa High School and San Diego Unified School District from and for any sums, costs or expenses (including attorney fees) incurred by any of the coaches, staff, volunteers or other representatives of the Amon Gordon Life Skills Football Camp, Mira Mesa High School or San Diego Unified School District, or paid by them to any person (including Participant or his/her insurers) in connection with any accident, injury (including death), loss or damage sustained by Participant or others in connection with Participant's attendance or participation at camp.

Photo and Video Release: I acknowledge that the Amon Gordon Life Skills Football Camp and his representatives may use photographs and video footage of Participant, with or without my name, for the lawful purpose of marketing, publicizing or promoting the Amon Gordon Life Skills Football Camp activities. I consent to such use, hereby waive all rights and compensation and authorize Amon Gordon Life Skills Football Camp, his assigns and transferees to copyright, use and publish the same in print or electronically.

Acknowledge and Consent: I acknowledge and accept that this Emergency Authorization, Disclaimer, Assumption of Risk, and Waiver is intended to be broad and inclusive as permitted by the laws of the state of California and agree that if any portion of this Emergency Authorization, Disclaimer, Assumption of Risk and Waiver is deemed to be invalid, the remainder will continue to be in full legal force and effect.

I have read the Emergency Authorization, Disclaimer, Assumption of Risk and Waiver and acknowledge that I fully understand and accept the terms of each. I understand that the Participant and I have given up substantial rights by my signing this form and agreeing to these terms, and I sign this form for myself and on the behalf of the Participant and agree to these terms freely and voluntarily and without inducement or undue influence.
